 - This case highlights the complexities of balancing private property rights, public infrastructure needs, and the constitutional limits on delegating governmental powers to private entities in the context of natural gas pipeline construction.
- Harris Cnty. Hosp. Dist. v. Public Util. Comm'n, 577 S.W.3d 370 (Tex. App.—Austin 2019, pet. denied)
 - This case dealt with fees paid to telephone companies and a 20 year old class action settlement. This complex case required an analysis of class action law and statutory construction.
- Cielo Prop. Grp. v. Mulcahy, No. 03-18-00587-CV, 2019 WL 3023312 (Tex. App.—Austin, pet. denied)
 - This was an interlocutory appeal where Cielo Property Group and its principals successfully challenged a district court's denial of their motion to compel arbitration in a dispute with former employee Branigan Mulcahy. The appeals court ruled that all of Mulcahy's claims, including those against individual principals, fall under the arbitration clause in his employment agreement with G&A Partners, despite Cielo not being a direct signatory.
